Affiliation Arrangement with WEST COAST GOLF CLUB

For Warren Golf & Country Club Members visiting this club:

1. SCOPE OF AFFILIATION ARRANGEMENTS

1.1 Restricted to Golfing Facilities only

- a) An Affiliated Member may use and enjoy, in common with other members of the Affiliated Club and persons permitted by the Affiliated Club and subject to the rules and regulations of the Affiliated Club, only the golfing facilities of the Affiliated Club, unless otherwise permitted by the Affiliated Club at its sole discretion.
- b) In this respect, golfing facilities shall include the golf courses, changing rooms, the driving range and any other facilities relating to golfing activities.
- c) An Affiliated Member shall, before using and enjoying the golfing facilities of the Affiliated Club, or whenever requested to do so, present to the Affiliated Club, a valid membership card of his Club.
- d) An affiliated member shall be restricted to play2 games per month, subject to availability of slots. Affiliated members wishing to play more than 2 games per month would require obtaining prior agreement from the host club and this is subject to the availability of slots.
- e) An affiliated member who reside permanently or on long-term temporary basis (more than 90 days at any one time) are not eligible to make use of the affiliation arrangements set out in this terms and conditions.
- f) As agreed upon, obligation relating to availability of starting times is as follows:

Affiliation Arrangements:

Weekdays (Monday – Friday only except public holiday)

Visiting members shall be entitled to play golf, subject to availability, at 50% of the prevailing guest green fee. Other fees will be at normal rates.

Weekends & Public Holidays

Visiting members shall be entitled to play golf, subject to availability, at **70% of the prevailing member guests' rate on weekend.** Other fees will be at normal rates.

Cancellation of bookings

Cancellation of bookings shall be made within 24 hours, failing which the visiting member may be levied a fee which is equivalent to the green fee. The Affiliated Golf Club is responsible to collect the levy and reimburse the host club within 2 weeks.

A member who frequently makes cancellation without advance notice may be suspended from playing on the course for at least 3 months.

1.2 Payments required to be made by an Affiliated Member

- a. A visiting member shall be required to pay the above agreed fee when using the golfing facilities at the Affiliated Club.
- b. A visiting member may introduce up to a maximum of three (3) guests to play at the Affiliated Club, subject to the rules and regulations of the Affiliated Club, and subject to payment of green fees for his guest or guests at the **prevailing visitor rate** charged by the Affiliated Club provided that the Affiliated Members shall be fully responsible for all acts and omissions of his guest or guests and all costs, expenses and liabilities whatsoever arising from such acts or omissions.
- c. A visiting member shall have no signing privileges and shall pay for all applicable golfing charges and for food and beverage consumed by him or his guest or guests, in cash or by credit card.

1.3 Booking of Starting Times

All bookings for staring times at the Affiliated Club shall be made by the respective Club for its members by way of Letter of introduction and shall contain sufficient information relating to the name, membership number and golf handicap of the Affiliated Member or his guests. Booking of slots shall be done three days in advance for weekdays and one week in advance for weekends/public holidays slots.

1.4 Suspension of an Affiliated Member

- a. An Affiliated Club may, if it considers that any Affiliated Member has conducted himself or herself in any way injurious to the Affiliated Club, or contrary to the interests of the Affiliated Club or has committed any breach of the rules and regulations of the Affiliated Club, suspend such Affiliated Member from his entitlement to the Affiliation Arrangement, or refuse him entry into the premises of the Affiliated Club.
- b. An Affiliated Member who has been suspended from the Affiliated Club shall cease to be entitled to the Affiliation Arrangement.

1.5 General

- a) The parties hereto agree and undertake to co-operate with each other in relation to the Reciprocal Arrangements in accordance with the provisions of this Agreement and the parties shall at all times act in such a way as to further the common interest of the parties respectively.
- b) Each Club agrees and undertakes to ensure that their respective members are familiar with the rules and regulations of the Reciprocated Club and in this respect each Club undertakes and covenants that the rules and regulations of the Reciprocated Club shall be posted on its notice board or available for inspection by its members at its clubhouse, free of charge.
