1. SCOPE OF RECIPROCAL ARRANGEMENTS

1.1. Restricted to Golfing Facilities only

- a) A Reciprocated Member may use and enjoy, in common with other members of the Reciprocated Club and persons permitted by the Reciprocated Club and subject to the rules and regulations of the Reciprocated Club, only the golfing facilities of the Reciprocated Club, unless otherwise permitted by the Reciprocated Club at its sole discretion.
- b) In this respect, golfing facilities shall include the golf course, changing rooms, the driving range and any other facilities relating to golfing activities.
- c) A Reciprocated Member shall, before using and enjoying the golfing facilities of the Reciprocated Club, or whenever requested to do so, present to the Reciprocated Club, a valid membership card of his Club.
- d) The period of this reciprocation in respect of each member is strictly limited to six (6) games in any one calendar year.
- e) The reciprocity does not extend to residents in and citizens of the visiting countries.
- f) As agreed upon, obligation relating to availability of starting times is as follows: Visiting members shall be entitled to play golf, subject to availability, without the payment of green fee. There shall be no restrictions on the number of flights available for booking by the reciprocated members on Weekdays. However on weekends and public holidays a maximum number of 3 flights may be taken up on any one day subject to booking availability.

1.2. Payments required to be made by a Reciprocated Member

- a) A Reciprocated Member may introduce up to a maximum of three (3) guests to play at the Reciprocated Club, subject to the rules and regulations of the Reciprocated Club, and subject to payment of green fees for his guest or guests at the prevailing guest rate charged by the Reciprocated Club provided that the Reciprocated Members shall be fully responsible for all acts and omissions of his guest or guests and all costs, expenses and liabilities whatsoever arising from such acts or omissions.

- b) A Reciprocated Member shall have no signing privileges and shall pay for all applicable golfing charges and for food and beverage consumed by him or his guest or guests, in cash or by credit card.

1.3. Booking of Starting Times

- a) All bookings for starting times at the Reciprocated Club shall be made by the respective Club for its members by way of Letter of Introduction and shall contain sufficient information relating to the name, membership number and golf handicap of the Reciprocated Member or his guest, and any substitution of golfers named in the booking shall be notified in writing by the Club to the Reciprocated Club, within a reasonable time before the starting time allocated for the golfers failing which no substitution of golfers shall be allowed by the Reciprocated Club.

1.4. Suspension of a Reciprocated Member

- a) A Reciprocated Club may, if it considers that any Reciprocated Member has conducted himself or herself in any way injurious to the Reciprocated Club, or contrary to the interests of the Reciprocated Club or has committed any breach of the rules and regulations of the Reciprocated Club, suspend such Reciprocated Member from his entitlement to the Reciprocal Arrangement, or refuse him entry into the premises of the Reciprocated Club.
- b) A Reciprocated Member who has been suspended from the Reciprocated Club shall cease to be entitled to the Reciprocal Arrangement.

1.5. General

- a) The parties hereto agree and undertake to co-operate with each other in relation to the Reciprocal Arrangements in accordance with the provisions of this Agreement and the parties shall at all times act in such a way as to further the common interest of the parties respectively.
- b) Each Club agrees and undertakes to ensure that their respective members are familiar with the rules and regulations of the Reciprocated Club and in this respect each Club undertakes and covenants that the rules and regulations of the Reciprocated Club shall be posted on its notice board or available for inspection by its members at its clubhouse, free of charge.
