## 1. Eligibility

- 1.1. All visiting members must be full active golfing members of either clubs.
- 1.2. Absentee or suspended members shall not be entitled to the below privileges.

## 2. Affiliation Terms & Conditions

- 2.1. Each of the two clubs shall extend to the visiting member of the other club all privileges usually given to its members
- 2.2. Visiting members shall be subject to all Rules, bye-laws and other controls in effect at the time of their visit.
- 2.3. Visiting members shall be eligible to play golf on all courses and affiliated courses at either clubs, subject to availability and the conditions below:-
- I. Member Guest Rates of the host club shall apply to all visiting members (Except on major competition days or course closures on weekdays.) Members are only allowed to play on weekends/public holidays after 12 noon based on availability. Earlier tee times may be given subject to availability on specific days during quiet periods.
- II. A Maximum of (5) flights a day shall be available.
  - 2.4. Visiting members wishing to avail themselves to these affiliation arrangements shall present-
    - a. A letter of introduction signed by the General Manager or his/her club (valid for 3 months);
    - b. A club membership card:
    - c. A valid handicap card equal to or below 36 for women and 28 for men
    - d. travel passport upon arrival at the Club

- 2.5. Each visiting member may bring a maximum of three (3) non-members/guests on each occasion. Non-members/guests will receive a discount from the published rack rate applicable at that time
- 2.6. On occasion, VIP guests of both Clubs may visit each club under the regulations set in clause 2.3., Each Club will be notified beforehand via associated Club's management. No more than 3 flights (12 golfers) per month are entitled to this privilege.
- 2.7. On occasion, Committee/Board members shall be entitled to affiliated privileges at either Club complementary of any green fees (caddie fees will still be payable). Each Club will be notified beforehand via affiliated Club's management with proof that visiting guest is a member of either Clubs BOD (Board of Directors).
- 2.8. Booking shall be made at least one (1) week in advance from the date of play on a first-come-first served basis.
- 2.9. It is preferable that should a member of one club intend to visit the other, that the member make the necessary arrangement for the booking of playing golf through his/her own club prior to the intended date(s) of play rather than booking direct.
- 2.10. Visiting members and their guests are not entitled to any credit or signing facilities and shall settle all expenses incurred during their visit upon registration or departure either by cash or credit card.
- 2.11. Visiting members may use the other sporting facilities based on availability, subject to the club's existing restrictions, rules and charges.
- 2.12. If a visiting member breaches the Rules, bye-laws or other regulations of the host club or if the conditions for affiliated golfing privileges herein are breached or not satisfied by a member, each club has the right to revoke or terminate all privileges to such visiting members and/or their guests. Such termination shall not be subject to any appeal or any course of action.
- 2.13. The terms and conditions herein stated may, by mutual agreement and in writing, be reviewed from time to time
