## 1. Eligibility

- 1.1 Only Full Members in good standing are eligible to enjoy affiliate privileges.
- 1.2 Absentee or suspended members are not entitled to reciprocal privileges.
- 1.3 Members and members' guest/s must reside outside the country of the Host Club.
- 1.4 A formal letter of introduction is required.
- 1.5 Members must present a valid membership card and passport or a valid identification card upon registration.
- 1.6 All visiting members and members' guest/s must hold a valid handicap certificate/card issued by the Home Club or local golf association.
- 1.7 All guests must be accompanied by affiliate member. Guests must present passport or a valid identification upon registration.

## 2. Booking of Golf

- 2.1 All bookings must be made through Warren Golf & Country Club.
- 2.2 Bookings are subject to availability and approval by the Host Club.
- 2.3 Bookings may be made up to (30) days in advance in accordance with the Host Club's reservation policy.
- 2.4 Confirmation of bookings is subject to the Host Club's scheduling and tee time availability.

## 3. Playing Privileges

- 3.1 Affiliate Members may play up to **twelve (12) rounds per calendar year**.
- 3.2 Play is restricted to **weekdays (Monday to Thursday), excluding Public Holidays**.
- 3.3 A limited number of flights may be allocated daily, subject to availability and Host Club approval.
- 3.4 Privileges may be suspended during peak periods, competitions, or special events.

## 4. Fees & Charges

- 4.1 Affiliate Members and members' guests are entitled to discounted green fees (inclusive of buggy fee).
- 4.2 All rates are based on the Host Club's prevailing public green fees at the time of booking and are subject to change.
- 4.3 Additional charges may apply, including caddy fees, and other incidental expenses.
- 4.4 Affiliate members are responsible for any damages caused and that of their guest/s at all times.

## **5. Guests**

5.1 Guest/s are subject to the Host Club's approval.

5.2 Each Affiliate Member may bring guest/s, subject to the Host Club's prevailing policies and rates.

5.3 All guest fees shall be payable at the applicable Host Club rates.

## **6. Cancellation Policy**

6.1 Cancellation notice of bookings should be sent to Host Club by the Home Club at least one week in advance in accordance with the Host Club's policy.

6.2 Failure to notify the Host Club within the specified period will result in the person/s being charged the full amount.

6.3 Repeated late cancellations or no-shows may result in suspension of booking privileges.

## **7. Use of Facilities**

7.1 Access to facilities is subject to the Host Club's Rules and Bye-Laws.

7.2 Affiliate Members are not permitted to participate in club competitions unless otherwise invited.

7.3 The Host Club reserves the right to refuse entry or restrict access to facilities at its discretion.

7.4 Facilities: Golf courses and associated leisure, entertainment, and hospitality services provided by the Host Club.

## **8. Additional Benefit**

8.1 Affiliate Members can enjoy a 15% discount on accommodation rates with Joondalup.

## **9. Member Responsibilities**

9.1 Members are responsible for their conduct and that of their guest/s at all times.

9.2 Members must comply with the Host Club's:

- Dress code
- Etiquette
- Pace of play guidelines
- Club policies and Local Rules

## **10. Payment**

10.1 All charges incurred must be settled directly with the Host Club prior to departure.

10.2 No credit or charging facilities will be extended to visiting members and members' guests.

10.3 Motorised buggy usage is compulsory and chargeable.

## **10. General Conditions**

10.1 Privileges are subject to change, suspension, or withdrawal without prior notice.

10.2 The Host Club's decision on all matters relating to play and access shall be final.
